WINTER NEWSLETTER



Winter taxes are due and payable without interest (including deferred parcels) until Friday, Feb. 14, 2025.

On March 1, delinquent taxes are turned over to the County and CANNOT be paid at the Township.

If your property taxes are paid via mortgage escrow, please contact the Treasurer's office to verify for billing purposes. Mortgage escrows can include financing, refinancing, or if you have recently paid off an existing mortgage loan.

DELINQUENT TAXES: FAQ

When are taxes considered delinquent? County Treasurer JoAnne Vukin will be holding a hearing on Jan 17, 2025 for the delinquent 2022 taxes, in the Commissioners Room, in Stanton.

Can I come ask for more time?

The hearing is where people, who may not be able to pay those delinquent taxes, can come and ask for more time. Treasurer cannot forgive the delinquent taxes, but does have the ability to extend the deadline to pay before foreclosure.

When do the 2022 taxes go to the judge?

In Feb of 2025 there is the Foreclosure Hearing before the circuit court judge. <u>You can petition</u> to court to withhold the taxes from foreclosure.

What is the last day to redeem 2022 taxes?

The judge will sign the Foreclosure order in February 2025, but people still can redeem the 2022 taxes until March 31, 2025 at the County Treasurer's office.

When are rights to property lost for failure to pay 2022 taxes? April 1, 2025
