The fund verification audit completed by Rehman Robison, however, the final report not available at meeting. The County has offered to split the differences of the variances and pay for the cost of the audit. BWL variance was \$16,835.24 (\$8,417.62) and LWL variance was \$4,412.52 (\$2,206.26).

Big Whitefish Sewer O/M Balance: \$263,473.76 + \$8,417.62 = \$271,891.38 Little Whitefish Sewer O/M Balance: \$81,129.17 + \$2,206.26 = \$83,335.43
